NOTE 1: These are the acceptable waste categories as they would be defined by SRM. We have deliberately avoided the use of certain “catch-all” categories such as xx xx 99. Should however our customers consign their waste in such a manner, SRM reserve the right to accept the consignment providing SRM have already ascertained that the stream is indeed safe and suitable to process.

NOTE 2: SRM Morecambe also operate a thermal oxidiser for burning clean waste streams, mainly internal arisings of process effluent from solvent recovery. Where any suitable input from the above list meets the strict waste specification (ie halogens content, metals content, ash) these streams may also be diverted to direct thermal recovery by burning on CU1. As these are comparatively insignificant arisings, this processing route has not been explicitly separated out in the above list.
